2. The school shall function as per the rules framed under the Karnataka Education Act, 1983 and the Children's Rights Education Act, 2009,

3. As per the rules framed under the Children's Rights Education Act, 2009, it is ought to reserve 25% of seats for children of weaker section. In the schools that come under the purview of RTE, the Government has the authority to enrol the seats reserved under RTE. (The Government has framed rules to facilitate enrolment of children in the nearby schools where the parents reside, accordingly in case Government schools or Grant in aid schools are available, then children shall be enrolled in these schools) Otherwise, the private schools should enrol those children enrolled by the Government and allow them to continue their education up to primary level without any discrimination.

4. As described in clause 3, Government would release the fees of those children enrolled under RTE rules. Hence, collection of fees from these children is banned.

5. Collection of any capitation fee and any form of voluntary donations from the parents during or after enrolment by the school and school management is prohibited.

6. The information of fees charged by the school / management as tuition fee from parents of children in their school vide State Government Notification No: ED: 31: PGC: 2019, Dated: 27.07.2019 should be published on the departmental website and on the school notice board. No fee shall be charged in excess of the prescribed fee.

7. The School / Management shall enroll the students within the period fixed by the Government.

8. The School / management cannot refuse enrolment against the following points,

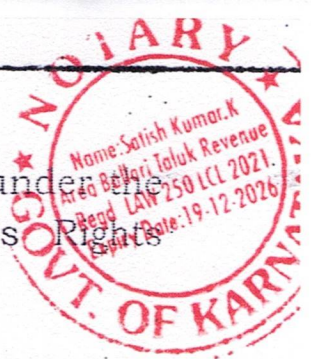

- (i) Due to lack of age proof.  
(ii) On the basis of caste, religion, place of birth, language,  
(iii) If admission is sought after extended period of admission.

9. Carrying out all safety measures as per RTE Act and Rules, Karnataka Education Act and Rules. [Related to Fire Safety and Building Safety Certificate from concerned authorities and Child Learning Safety per K.S.C.P.C.R and N.C.P.C.R.).

10. The School/management is as follows

- (i) any admitted student shall not be held back in any class or expelled from the school till the completion of primary education and secondary education  
(ii) No child shall be subjected to physical or mental abuse.  
(iii) No child shall be required to pass any board examination till completion of primary education.  
(iv) Every child who completes primary education under Rule 21 of RTE and Karnataka Education Act and Rules, a prescribed Certificate will be issued.  
(v) As per the provisions of the RTE Act and Rules and the Karnataka Education Act and Rules, the school shall also admit children with special needs / special children.  
(vi) Appointed teachers shall possess the minimum qualifications as prescribed for primary and high school teachers in the RTE Act and Rules and Government orders.  
(vii) Salary and allowances payable to teachers and terms and conditions of service shall be as prescribed by the State Government. And as per government notification the benefits of Provident Fund (PF) and Employee State Insurance (ESI) shall be extended to the teachers. Salaries are paid to teachers through bank.  
(viii) Teachers shall perform the duties prescribed under Section 24[1] of the Act and the RTE Act and Rules and Rule 17 of the Karnataka Education Act and Rules and shall not engage themselves in private tuitions for supervisory considerations.

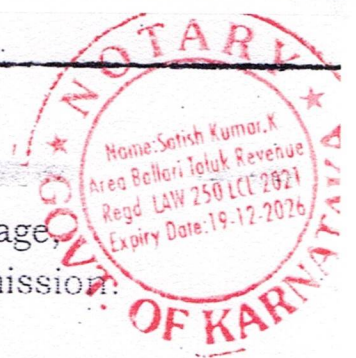

11. Adherence to the academic state curriculum and state text books to which the school is affiliated.

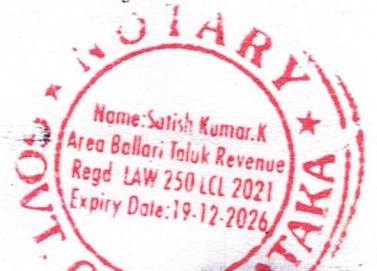
